## Change in the Executive Board of Groupe Mutuel

**Martigny, 9 April 2024. Mr Paul Rabaglia, CFO of Groupe Mutuel and a member of its Executive Board, has decided to step down while remaining active within the company. To replace him, Mr François Murer will become the new CFO of Groupe Mutuel from 1 September 2024, following a transition phase.**

After spending close to 30 years in various managerial positions within Groupe Mutuel, Paul Rabaglia has decided to step down to facilitate the transition in the Finance Department while maintaining a role within the company. He will therefore resign as CFO and member of the Executive Board with effect from 31 August 2024.

To replace him, the Board has decided to appoint François Murer as CFO and member of the Executive Board from 1 September 2024. François Murer is 38 years old, holds a master's degree in actuarial science and has extensive experience in both actuarial matters and asset management. He previously worked in insurance at La Mobilière, where he was head of financial planning and then head of products for the life insurance company. He joined Groupe Mutuel in 2020 as head of the "Health & Pensions Development" department. In his current role, he is responsible for the range of products for private customers and for the operational management of GMV life insurance company.

François Murer will join the Finance department on 1 May 2024 and will work alongside Paul Rabaglia until September, during the transition phase.

"I would like to thank Paul Rabaglia for his commitment to the Executive Board. His knowledge of the company and his cross-sector approach have helped to strengthen and further develop Groupe Mutuel. I will be delighted to be able to count on him in his new role over the coming years. Furthermore, I very much look forward to welcoming François Murer to the Executive Board. His experience in actuarial work, asset management and financial planning will help strengthen the Finance department", said Thomas Boyer, CEO of Groupe Mutuel.
